
Sure, we know you know about all these things, but perhaps you are a bit rusty, and who knows a program that provides a person with just ONE idea, surely hasn't been lost time. So

Dr. Bernard Berman, speaking on the subject of the "Simple Approach to Photography" provided the audience this meeting with a witty, pleasant present-

ation of his photographic experiences.

His reminder on the kind of equipment to use, being based on what's good for one is not always good for another, certainly is a practical thought. He personally carries the smallest amount possible believing that photography is for Fun, so why be encumbered with so much that it becomes a big work project. It also seems he limits his concern for photographic data records to a minimum.

A few quickies -- Fill the negative with as much as possible --- Cropping in the enlarger, where he gets a lot of enjoyment out of his p icture taking ---Everyone needs "applause" so he hangs some of his work in his waiting room(he's a Dentist) and "hopes" --- Believes in Titling pictures --- Washington has 10 miles that offers the best photography of anywhere in the world --- Sees a picture, takes it, and likes it, whether anyone else does or not, that's his satisfaction --- Proper mounting is an important phase, too often neglected ---Alert to more than one picture out of a negative --- His definition of the simple approach is never show anyone your bad pictures.

Exhibit and contest wise, he has been a consistent winner of the Star Snapshot Contest, preferring to compete under these conditions. He keeps with his entries the clippings relating to his pictures and based a good deal of his talk to us on the selection of prints that have made the grade here for many years. It was interesting to note the cycles of popularity of the subject matter that



By the time of the next issue of the Cable Release, Leon Rothenverg will have made his trip to Puerto Roco, where he also hopes to get in some picture taking.



GWCCC INTER - CLUB COMPETITION

The next Inter-Club Competition, will be in March. The deadline for Camera Club entries has been set

for Tuesday, March 6.

In the interest of trying to get a full entry for the Silver Spring Clubm members are asked to bring their submissions to any of the forthcoming meetings, indicating that they are for consideration for the Club entry. However, Thursday, February 15 is being assigned as entry night for PRINTS, and Thursday, March 1, for SLIDES. REMEMBER these DATES.

A committee of Club members will screen the submissions and record the accepted entries to comply with the rules for Club entry for this Competition.

The rules are the same as the last competition. There will be two calsses of Monochrome; the SMALL PRINT DIVISION, not to exceed 8x10, mountd on not to exceed 16 x 20, and limited to competitions, who have not won medals in previos GWCCC's; the UNLIMITED PRINT DIVISION, any size print, mount to be 16 x 20. Individuals may compete in only one of the monochrome classes; toning of prints is permitted; COLOR TRANSPARENCIES , 2 x2 and 2 3/4 x 2 3/4 slides are eliligible.

So members bring your pictures, make your personal preferences of your entrries

known, and help the club to submit an outstanding entry this time.

Reminder of importance: Prints - each mount must bear on its back - title of print - name - address of maker - and club through which submitted. Print Title must appear on front of mount - maker's name on front Optional. Slides must bear title - maker's name and club through which submitted. Slide to be THUMB MARKED in LOWER LEFT HAND CORNER as normally viewed, before projection. Slides are handled in very dim light and it is important that this be neat and legible. ******

Members are asked to pick up their entries from the last Inter-Club Competition. Mrs. Wertz has the Slides and Prints and would like to get them back to their owners.

Entries are limited to 4 in each division or 4 slides and 4 prints, sizes 8 x 10 or larger, mounted on 16 x 20 - slide sizes 2 x2 or 2 1/4 x 2 1/4 - been taken within last five years - makers name must not appear on front of mount.

HYPO DRIPPINGS

From "Better Photography Made Easy" by Ansco. SIMPLE TRICK PICTURES - turn one of your friends into "twins" or "triplets"- required a very dark background, a dark illuminated wall, or shoot toward an open door if there is unbroken darkness beyond. Pose subject at one side of background- make normal exposure with camera on tripod or firm support. Move subject to other side of background, do not overlap, and without moving camera or advancing film make another normal exposure. You can show a friend as twins shapping himself on back, or whateverif background area is large as many as four such moves could be made.
