## CONSTITUTION AND BY-LAWS

### OF THE

# SILVER SPRING CAMERA CLUB

## Article 1 - PREAMBLE TO A STATE OF THE PROPERTY OF THE PROPERT

This club is formed to provide members of the community with an educational-recreational program through the medium of photography.

### Article 2 - NAME

The name of this club shall be "Silver Spring Camera Club."

### Article 3 - CLUB EMBLEM AND COLORS

Section 1 The Club Emblem shall be an Acorn whose design follows that of the Springhouse at the original Silver Spring.

Section 2 The Club Colors shall be orange and black.

### Article 4 - OBJECTIVE AND PURPOSES

Section 1 The objective of the club is to provide a common meeting place for those residents of the Silver Spring area who are interested in the science and art of photography.

Section 2 Its purposes are to hold meetings, classes, lectures, and demonstrations of the various phases of photography, scheduled competitions, and annual salons to encourage members to increase their knowledge of, and skills in, photography.

### Article 5 - MEMBERSHIP

Section 1 Membership shall be open to all persons whose applications have been approved by the Board. 'Membership shall be denied to applicants whose association with the club could jeopardize the well-being of the membership, the integrity of the club, or the government interests of the United States."

Section 2 Additional classes of members may be provided for by proper amendment to this Constitution and By-Laws.

### Article 6 - BOARD OF DIRECTORS

Section 1 The Board of Directors shall consist of the current officers of the Club and three elected directors.

Section 2 One Director shall be elected for a three year term at each regular election. There will be three elected directors on the board.

- Section 3 The elected officers shall hold the same offices on the Board as in the Club.
- Section 4 The Board shall have authority to fill vacancies in its membership, except that the Vice-President shall succeed to the presidency in case of a vacancy in that office.
- Section 5 Chairmen of the various committees shall sit with the Board, and shall have a vote.
- Section 6 It shall be the duty of the Board to supervise the affairs of the Club, admit new members, coordinate the activities of the various committees, and approve expenditures of Club funds.
- Section 7 The Board shall decide the day and hour of its meetings. Three members of the Board, including an elected member other than an officer, may call a meeting of the Board upon notice of at least one week in advance of the meeting.
- Section 8 Minutes of the Board meetings shall be kept by the Secretary.
- Section 9 The Board may adopt such rules and regulations for its activities as are necessary so long as they are not contrary to this <u>Constitution and By-Laws</u>.

### Article 7 - OFFICERS

- Section 1 The officers of this Club shall be:
  - A President
  - A Vice-President
  - A Secretary
  - A Treasurer, who shall also be Chairman of the Finance Committee.
- Section 2 All officers shall be elected from the membership of the Club for a period of one year or until their successors are elected and qualified.
- Section 3 The duties of such officers shall be those ordinarily associated with the office held.
- Section 4 The secretary shall keep a record of each club competition and interclub competition including a list of members competing, title and ranking of winning photographs.

### Article 8 - MEETINGS - RIGHT TO PETITION

- Section 1 Regular Club meeting dates shall be the first and third Thursday of each month from September thru May.
- Section 2 Members are entitled to present a question to the executive board.
- Section 3 To overide the decision of the board on the specific question brought to the board a petition must be signed by 15 members in good standing to bring the question to a vote by the membership at the next regular meeting.

### Article 9 - QUORUM

Section 1 A quorum for the transaction of business at a Club meeting shall be 1/3 of the membership in good standing.

Section 2 A quorum of the Board shall be four, one of whom must be a Director without office.

### Article 10 - FISCAL YEAR

The fiscal year of the Club shall begin July 1, and end June 30 of the following year.

### Article 11 - DUES AND ASSESSMENTS

- Dues shall be \$7.50 per year per member or family of husband and wife.

  Dues are payable for the year and due the first meeting in September.

  New members joining February 1 or later shall pay dues of \$4.00 for the remainder of the club year. Dues for high school students and full time undergraduate college students will be \$5.00 per year.
- Section 2 Specific assessments must be approved by the executive board and members notified through the club publication prior to the date of any such assessment.
- Section 3 Special assessments or fees for attending classes or lectures and demonstrations shall be set with approval of the Board.

### Article 12 - COMMITTEES

- Section 1 Special Committees or special members on Committees may be appointed by the President or his substitute. Such Special Committees or members shall continue to function until the service for which they were appointed is completed, or until discharged by the President. In any case their appointments shall not extend beyond the close of the fiscal year in which appointed.
- Section 2 Standing Committees. The President with approval of the Board shall, when necessary, initiate the following committees whose tenure shall cease with the expiration of the fiscal year. The President will appoint the chairman.
  - A. Program Committee for color, whose duty shall be to conduct meetings or portions of meetings devoted to color. This shall include the securing of speakers, judges, etc., when desirable, and the conduct of color competition.
  - B. Program Committee for Monochrome (black and white) photography, whose duty shall be to conduct meetings or parts of meetings devoted to monochrome. This shall include the securing of speakers, judges, etc., when desirable and the conduct of monochrome competition.
  - C. Finance Committee. The Treasurer is Chairman of the committee. This committee shall prepare a proposed budget to be submitted to the President prior to the September meeting. This committee shall cause an audit of the Treasurers books of account to be made twice a year and presented for the approval of the President.
  - D. Field Trip Committee. It shall be the duty of this Committee to arrange for and take charge of entertainments, hikes, and outings.
  - E. Membership Committee. This Committee is responsible for securing

new members, receiving their applications; relaying them to the Board for action, and providing membership cards. The Vice-President heads this committee.

F. Work Shop Committee. The Work Shop Committee shall provide lectures, demonstrations or classes for the advancement of

the members in photography.

G. Publication Committee. This Committee shall publish a news letter for the benefit of the membership. Also it shall arrange for publicity for the activities of the Club.

H. Library Committee. The Library Committee shall cooperate with the Public Library, and when feasible shall establish and operate a Club Library, with authority to make the rules

necessary for its proper maintainence and operation.

I. Nomination and Elections Committee. It shall be the duty of the committee to present the slate of officers at the first meeting in April. Following the submission of the report, nominations may be made from the floor. Neither the slate nor the nominations from the floor require a second, however, each candidate must state his willingness to serve in the office to the committee. Elections are held the first meeting in May.

The nominating committee shall also be available to assist the President in filling all chairmanships on the Executive Board and will serve until all such positions are filled.

J. Hospitality. This committee shall greet guests, and prepare refreshments at the club meetings.

K. Exhibits Committee. This committee shall make arrangements and be responsible for club exhibits.

Article 13 - INSTALLATION OF OFFICERS

Officers are installed at the Year End Banquet.

### Article 14 - AFFILIATION

This Club may affiliate with such recreational and educational organizations as the Board may deem advisable.

### Article 15 - AMENDMENTS

This document may be amended by a 2/3 vote of the membership. Amendments may be proposed by any club member. A proposed amendment may not be voted on at the meeting proposed, but shall be voted on not later than the second meeting following its submission.

### Article 16 - INCORPORATION

At the discretion of the Board this Club may be incorporated,
