WASHINGTON SALON OF PHOTOGRAPHY

All members are urged to participate in the Washington Salon of Photography. This is the greatest photography contest and exhibit annually held in this area. You should enter your slides and prints, see the judging and view the exhibits. Much can be learned by doing all or any of these things.

Entries Here is the chance for each person to stand his work up alongside the best produced throughout the world. Special arrangements have been made to make it easy for local photographers to enter. Entrance fees are only \$1.25 for either slides or prints provided that the entrant make arrangements to pick up his entry at the processing station on the mailing date. Of course the entry may be picked up by another person such as the club's representative to the salon. There will be delivery service between the slide processing station at the home of Mr. George Dodrill and the print processing station in Town Hall Auditorium at Tyson's Corner Shopping Center. In this way entries could be delivered both to and from the salon by the club representative regardless of which section he is working with.

SSCC's Representative is Emerson Gray. He has entry forms and detailed information sheets regarding the salon. See him at the Color meeting on March 7th, or phone 762-8415. Entries must be in by March 19th, 1974.

Judging The judging of the salon will be in two locations. Pictorial slides, Nature (both slides and prints), and Photo-Journalism (both slides and prints) will be judged at the Washington Gas Light Co.'s Operations Bldg., 6801 Industrial Rd., No. Springfield, Va. It will start on Friday night, March 22, 1974, with Pictorial Slides in the large auditorium and Photo-Journalism Slides in the small auditorium. The judging will be continued on Sat. morning with Nature in the small auditorium. In the event that any of these sections receive more entries than is now anticipated or if the judging does not progress rapidly enough, it may be continued on Sunday morning. The Washington Gas Light Co. Operations Bldg. is located in an area bounded by the Capital Beltway, I-495, Shirley Highway, I-95, Backlick Rd. and Edsall Rd. Exit from Shirley Highway at either Edsall Rd. or Keenes Mill Rd. and exit from Capital Beltway at Braddock Rd.

Pictorial Prints, both monochrome and color will be judged at the Town Hall Auditorium, Tysons Corner Shopping Center, starting on Sat. morning, March 23, 1974, and will be followed in the same location by Stereo Slides. All of the judging will be open to the public and free of charge.

Photo-Travel Slides will be judged on Tues. night, March 26, 1974, at a location to be announced later.

Exhibitions Prints will be exhibited in the public mall area of the Tysons Corner Shopping Center, McLean, Va., from April 21 through April 28, 1974. This shopping center is located in the triangle formed by the Capital Beltway, (I-495,) Dolly Madison Blvd. (Va. Highway 123) and the Leesburg Pike (Va. Highway 7). The same prints will then be exhibited in the ground floor lobby of the FDIC Bldg., 550 17th St. N.W., Washington, D.C., for the next three weeks, from April 30 through May 17, 1974. The FDIC building is located across the street from the Executive Office Bldg. of the White House.

Slides will be available for exhibition to any interested groups between April 2, 1974, and April 30, 1974, as well as to be publicly exhibited at the following times and places:
