OUT DAMNED SPOT! This month's column deals with the removal of spots, scratches and other print faults, whether due to you or circumstances beyond your control.

Frequently, a white spot will occur on a black and white print due to a clumping of silver grains, or-Heaven forbid-because of dust, hair, or other detritus upon your negative. Since you labored for hours to produce the print-dodged one corner, burned a triangular odd shaped area for 37 minutes and blew your enlarger bulb-you don't want to redo the print.

How to get rid of the white spot? Of the many choices available, one of the most popular products is a "system" called SpoTone. The group of products consist of several "dyes" (this may not be technically accurate, but is descriptive) of various colors, each approximating a tone produced in black and white photographic papers. SpoTone comes with explicit instructions for blending the various individual colors to match specific papers. You can buy a three color assortment which has SpoTone products #0, #1, and #3. Unfortunately, one of the most useful colors is #2, which must be bought separately! With these four colors, you can probably match or very closely approximate the grays and blacks of just about any existing black and white paper.

A word of advice, however--if you follow the instructions, you will end up using considerable amounts of the "dyes" each time, far more than you need at one time. I decided on a color mixture which blends well with all the different papers I use (maybe not exactly, but close enough). I mix it up following the proportions I worked out to my liking, and keep it in a baby food jar. Some photographers allow the miture to dry out and then use it like a water color paint.

Now that you have your color mixture prepared, what do you do with it? Pout it on? NO!! The hardest thing to learn in "spotting" prints is to be PATIENT and to work with extremely small amounts of "dye".

First, and most importantly, dilute your dye mixture so that you can build up the desired tone density gradually. Once applied, the "dyes" are fairly permanent! Next, something I learned the hard way, buy the thinnest brush you can. I found a 00000 brush at Visual Systems in Rockville. Before club members told me of this, I used a much thicker brush (anything is thicker than 00000) and found myself creating dark rings around my white spots, actually making them look worse! Now, dip the tip of the brush into the "dye" dilution, and then WIPE the brush on a sheet of plain paper, or tissue, or something. It should JUST BARELY be moist with the dye. Take the brush and JUST BARELY touch the spot. If the spot is large enough, use a stippling technique; repeat this dipping, wiping, and stippling. Gradually, but perceptibly, the spot will get gray and then darker and darker. When it reaches a density which looks good to your eye, STOP! If it is a white spot in a totally black area, you will have to get it quite dark. However, if a white spot is in something like a face or cloudy sky, it may not be necessary to darken it very much before the spot vanishes in its surroundings! Don't be disappointed at first. This takes a lot of practice (or am I a slow learner).

The makers of SpoTone also offer a product called "Spot-off" for lightening or removal of dark spots, plus a set of 14 dyes for retouching, correcting and/or spotting color prints. While I've never tried this product, I understand that it is extremely difficult to match colors well enough to hide a spot of any great magnitude. The answer here is to be meticulous with your negatives (which we all should always be anyway, right?!)!

These dates are <u>final-firm</u> because all works must be delivered to Baltimore on the evening of March 7. Don't hesitate to

participate in these competitions. Timely transfers as necessary are guaranteed between CMCC and GWCCC club competitions.

If you are looking for a photographic (or general goods) bargain then you might want to explore Trade Fair, at 11910 Parklawn Drive, Rockville, across from Loehman's Plaza.

All sorts of items are available from this "estate" clearance operation, at reasonable or better prices. One of our club members, for example, recently purchased a Minolta SRT 101 body for \$47, mint condition, and a Honeywell 360 Strobonar for only \$8, with the battery charger.

However, it is definitely a CAVEAT EMPTOR situation. You see, all sales are final and items are sold "AS IS". Therefore, if you are unfamiliar with the item you would like to purchase, or you are not willing to experiment or gamble, then its a good idea to bring someone with you who is either knowledgeable or willing to take the chance. We know of one customer, for instance, who purchased a Vivitar 135mm lens that did not focus properly at infinity. However, for the paltry price paid he was willing to experiment with the lens and he managed to carefully correct the problem.

We offer this advice for your information only. This is not an advertisement paid by Trade Fair, nor a SSCC endorsement.
