#### A Word from the President

In Memory of Godfrey Frankel

Our hearts are saddened by the loss of Godfrey Frankel, who died of congestive heart failure on July 11, 1995 at George Washington University Hospital. Godfrey, age 82, and a member of the Silver Spring Camera Club since 1985, began his career as a newspaper reporter in Ohio in the 1930's and moved to Washington in the 1940's where he worked as the nightclub columnist for the Washington Daily News. It was during this time that he began spending his afternoons and early evenings exploring the back alleys of downtown Washington, Capitol Hill and Southwest Washington by bicycle, carrying his camera with him. His collection of photographs from this period, according to an article by Bart Barnes, Washington Post Staff Writer, depicts "the all-but-forgotten world of poor and crowded communities close to but virtually hidden from the broad avenues and monuments of the federal city."

According to his wife Lillian, Godfrey was active in the Newspaper Guild in the 1940's, and through the Guild he met Eleanor Roosevelt. He served as its Executive Secretary for a period of time.

After World War II, Godfrey left journalism to work for the Department of Interior in programs to resettle Japanese Americans, interned in wartime relocation camps, and to ease their return to US communities. A Native of Cleveland, he had earned a bachelors degree in liberal arts, and a masters degree in social work. He worked in a Cleveland community center until 1952 when he return to Washington to work in federal programs for the elderly. He

retired from government in 1982 as a program director for the National Institute on Drug Abuse. Although he made a career in government, Lillian said he never lost his love for photography. While in Cleveland he entered his photos in the May Show every year and received numerous honors and awards. He had also documented urban scenes of New York, and industrial areas of Cleveland, Ohio and Martinsburg, WV.

He earned a bachelor's degree in Fine Arts in 1988 from the University of Maryland.

Godfrey's fascination with the alley neighborhoods continued long after most of them were demolished to make way for urban renewal and their residents moved elsewhere. This fall the Smithsonian Institution Press will publish a book of his photographs, "In The Alleys: Kids in the Shadow of the Capitol", with accompanying text by freelance writer Laura Goldstein. An exhibit marking the publication of the book will be opened at the Hemphill Fine Art Gallery, 1027 33rd St. N.W. on September 7, 1995.

Godfrey's work was exhibited by the Kathleen Ewing Gallery in a show entitled "Images Out of the Ordinary" in 1992. His work was also featured in an article in the Washington Post Magazine, and a portfolio of his work was presented at the SSCC print meeting in April 1993. His photographs are included in the permanent collections at the National Museum of American Art, the Corcoran Gallery of Art, the Cleveland Museum, and the Museum of Modern Art in New York.

#### September 7, 1995 Slide Meeting, Silgo Creek by Merl Hoar

Our speaker for the September 7th Meeting, and judge for the slide competition, will be Dirk Zipf. Mr. Zipf works primarily in 35mm transparencies, but also uses negative films. His interest in photography began as a hobbyist and was encouraged by frequent travel. His subject matter varies from landscapes to architectural photography.

Mr. Zipf's background is in advertising sales, printing and publishing, and he has been fortunate to be able to merge his photography into his business. He established Visual Display Group, located in Virginia, as a signage and custom display broker and producer. His clients sometimes use his stock photography as part of their exhibit or photomural, and he occasionally performs on-site location photography.

His work has been published in Stevenson Calendars, local newspapers and national trade magazine covers. He has won top prizes in Washington Post photo contests, and has published color postcards. He also has experience judging camera clubs.

#### New Directions Workshop: Garry Kreizman Meeting Thursday, September 14 at my house 7:p.m.

Judging the Monthly Competitions by Mel Lewis

I don't know Arthur Yellin personally. Perhaps if I did I could better understand his frequent lamentations about the judging of the monthly competitions. Mr. Yellin's concerns are many and varied; however, I believe they may be fairly summarized in the following: Mr. Yellin doesn't like the competitions because he doesn't receive recognition for his work. In short, he doesn't win. It is a curious thing, but Mr. Yellin seems to require outside validation of his photography in order to enjoy the competitions, or even, perhaps, to enjoy photography.

Judging is a personal process and frequently any number of presented images could win. We all have seen how very uncomfortable some of the judges are about the entire process. They are in a position where they are asked to select some photographs over other photographs that are of equal merit. However, the judge, a volunteer, must make his selections and it is quite possible that few club members will agree with his selections. So what ? The uniformity in judging that Mr. Yellin seeks can not be achieved since each and every judge brings his or her perspective to the judging and however flawed the process may be it is doubtful that another better way could be formulated that would be more satisfactory.

Let us enjoy the competitions for what they are: a way to show our photographs to others, and to hopefully learn how to take better photographs from the comments of the judges concerning all the photographs shown.

#### Pictures on Disk by Bill Greene

Electronic image manipulation or photo diddling (depending on where you sit!) is a topic on which most photographers have a minimum of at least one firmly held opinion. Therefore, I was pleased to run across a cheap, easy way for serious photographers/computer novices to find out more about electronic imaging without raising the competition issue. In ye olde tymes this was known as having fun!

What is the secret? Just send a roll of film off to SeattleFilmWorks (SFW), and order prints, slides, and images on a standard diskette. The cost is about \$20 and includes a free copy of the PhotoWorks software (which should run on most current Windows PCs). I sent my own Kodak Gold 400, but you can also use SFW's "free" respooled movie film (ASA 200 or 400, 20 exposures). The software and photos, "Pictures on Disk," installed quickly, and I was ready to roll.

First, a Wizard appeared which helped create an album from my pictures. The next step was selecting a slide show to display the pictures in the album. I could choose how long each image stayed on, the type of fade between images, add a title, and all sorts of other neat stuff. Push a button on the toolbar (start, stop, backup, tast forward, etc.) and sit back and watch the slides go by. The colors on the monitor screen compared favorably with SFW's machine-processed color prints. (The slides tend to be overexposed).

Now comes the "Enhancer" function, an introduction to image manipulation. Here you can take one of your own images and perform several simple operations, viz., resizing, rotating, cropping, blurring, and sharpening. More complicated effects include warping, embossing, highlighting edges, and applying color filters. You can even sandwich two entire images; however, bits of two images cannot be combined to form a new single image. The final image can be put in your album for use in the slide show.

The most fascinating, and probably most difficult, aspect of FilmWorks is its ability to manipulate colors. For folks like me who are not color printers, here is the opportunity to learn about color curves, hue, saturation, lightness, brightness, contrast, and histograms. The results of changing any of these factors can be observed on the screen immediately after an adjustment is made.

Please note that, as promised, the question of entering the modified images in competition never comes up because of experimenting with PhotoWorks. The program allows for printing, but photographic quality should not be anticipated. Likewise, anyone with the expertise to make slides from the edited images would, for technical reasons, choose or already be using a professional level program.

PhotoWorks provides insight to image manipulation, affords training in handling color, and is just plain fun. It also lets you use your own images as screen savers. You should try the freebie version of the software first to see if you are interested. If so, I recommend ordering the full version with a 70-page manual (PhotoWorks Plus, which is what I have really described above) for about \$15.00. You may find you like computerized image manipulation. You may go on to bigger things from Adobe or Corel. You also may think it's (still) not photography. Who knows? Doesn't matter! One thing is certain. If you're a "nonbeliever," you will be in better position to hold up your end of the continuing argument!

### Then and Now by Mel Lewis

In the April 30, 1995 issue of the New York Times, Sara Boxer wrote a very perceptive and thought provoking article on documentary photography in this country. The occasion of the article was an exhibition of Dorthea Lange's depression photographs and Joseph Rodriguez's photographs of gang life in east L.A. We are all familiar with Lange's work and as we look at these familiar images we are apt to nod to ourselves and think of what these people endured; one can not help but feel empathy for the humanity portrayed in these photographs. Boxer contrasts this empathy with the feelings summoned forth by the Rodriguez photographs that present a world of violence and death.

Ms. Boxer goes on to discuss the history of documentary photography in this country and mentions the work of Jacob Riis, Walker Evans, and Dorthea Lange as playing a role alleviating the conditions portrayed. This is a debatable point, but is certainly a valid way to regard the issue. Ms. Boxer believes that in our present time documentary photography is "more and more detached from its original message." She cites the work of Andres Serrano as producing powerful work. One could also add the names of Lee Shelby and his work in Appalachia and Lee

Richards photographs of life in the inner city. Ms. Boxer states that the viewer seems to recoil from the starkness of the Rodriguez photographs. One could also mention the indelible of photograph of Eugene Richards of a crack addict preparing to perform fellatio with a young child draped across her neck. Ms. Boxer concludes that no matter how our feelings are exercised we are left with the feeling of a helplessness that we did not have in the 1930's. Somehow the problems of today seem too immense to be even partially ameliorated by photography. Another way of saying this is that the photograph's of Lange, Evans, Riis, etc. are all safely tucked away in our collective memory. They rest there peaceably, sanitized by time. By contrast the present is unmeditated, too tangible, too here, certainly too threatening.

#### July 15, 1995 Board Meeting:

The feasibility of getting a phone with voice mail for the camera club. Elizabeth and Gary were empowered to get the ball rolling as long as the cost does not exceed \$300.00.

Mike Stein has set up the forum for the computer workshop. Mike has set up a home page on the internet for his work.

The final discussion of the night was in regard to having the title of the photographs read at a competition. Comments describing the photograph could also be read by the handler. It was recommended that this be tried during a critique meeting. It was decided that this would be tried at the March critique meeting.

The meeting was adjourned.

# Silver Spring Camera Club Competition Rules and Awards (3/95)

#### I General

1. A competition is defined as a judging of photographs of a particular category made by entrants competing in a

particular category induce by entrants competing in a particular class.

2. Entrants must be members in good standing of SSCC meaning dues must be paid. Members from the prior year must have dues paid by Oct. 31st.

3. The competition chairperson (or person acting in their stead) shall be responsible for the administration of these

rules and may disqualify and remove any entry not conforming to these rules.

4. The judge(s) shall be instructed to reject any entry not conforming to an announced subject and/or technique category. It is the duty of the competition chairperson to be instruct the judge(s) in the definitions of subjects and so instruct the judge(s) in the definitions of subjects and categories.

# **II** Categories

1. There shall be three categories of competition: Monochrome Prints, Color Prints, and Slides.

2. Entries in all categories must have been photographed

3. Monochrome - initial film processing may be done by others but only under the direction of the entrant. All subsequent steps including retouching must be done by

4. Color - initial film processing and any associated production of an internegative may be done by others but

only under the direction of the entrant. All subsequent steps including retouching must be done by the entrant.

5. <u>Slides</u> – initial film processing and mounting may be done by any outside commercial lab. Any further steps in the production of the entry must be done under the direction of the entrant.

direction of the entrant.

6. Print entries may be mounted on boards of a size acceptable for the club's print viewing box (approx. 24" high); total print area may not exceed 11" x 14" for novice class; 16" x 20" for advanced class. The title and entrant's name must appear only on the back, there shall be no books or protruding objects on the mount board and the name must appear <u>only</u> on the back, there shall be no hooks or protruding objects on the mount board and the top of the print shall be clearly indicated by an arrow on the back of the mount board. A sequence of related prints, mounted on one board, will be considered as a single entry. For both classes the combined picture area of this sequence may not exceed 16" x 20".

7. Slides must be in 2" x 2" mounts suitable for projection in the Club's projector. The slide shall be marked with a clearly visible and distinct spot located in the lower left hand corner of the mount on the side facing the viewer when the hand-held slide is viewed in its correct orientation. The name of the entrant and the title of the

orientation. The name of the entrant and the title of the slide must be on the reverse side of the mount.

## III Classes

 Each category of competition (Monochrome Prints, Color Prints, and Slides) shall have two classes: <u>Novice</u> and Advanced.

2. A member's class standing in one category shall have no bearing on that member's standing in any other

category.

3. Except as noted later in this paragraph, a member may begin competing in any class of any category and may

move to the next higher class at any time. A member who has entered in a particular class however may not thereafter enter in a lower class. Whenever there are insufficient entries to have a Novice competition, a Novice member may choose to enter the Advanced class competition following Advanced class rules without affecting his or her status in the Novice class and any points awarded that member in that competition will be tallied in the Novice class.

tallied in the Novice class.

4. Point scores will be recorded and tallied by the Chairperson of the Competition Committee. A Novice entrant who has accumulated 36 points over any period, in SSCC monthly competitions, must move to advanced

class.

# IV Monthly Competitions

 A slide competition will be held on the first Thursday of each month, September through May during the regular club meeting except that one month may be designated for other purposes.

Monochrome and Color Print competitions will be held on the third Thursday of each month during the regular club meeting except that one month may be designated for

3. In a competition category, each entrant may enter a maximum of two slides, four novice prints or three advanced prints.

4. To conduct a Novice competition, there must be at least four entries by at least three entrants.

To conduct an Advanced competition, there must be a

minimum of nine entries. 5. Prior to competition, the title of each entry and the entrant's name must be recorded in the proper book as maintained by the Chairperson of the Competition

Committee.

No entry which has won an award in an SSCC monthly competition may be re-entered. No entry may be entered in more than three monthly competitions. Anyone submitting an entry more than three times will, on the first occurrence, be given a warning. Any further violation of this rule will result in a penalty of six points per infraction, to be deducted from the total points previously acquired by that member in that extension.

by that member in that category.

7. Awards will be presented in each competition based on the total number of entries in each class. Awards will be

valued as:

1st Place -6 points. 2nd Place-4 points 2 points 3 rd Place-1 point

The number of HM's will be based on 10% of the total entries in each class rounded up from odd multiples of five. No HM's will be awarded in competitions with fewer than 12 entries, no 3rd place with fewer than 9 entries and no 2nd place with fewer than 6 entries.

8. The Board of Directors may assign not more than one half of the monthly competitions to a defined subject and/or technique. All others shall be open. Such restricted competitions shall be scheduled and defined in the May Cable Release for the following year. Novice print competition shall always be OPEN.

# V Body of Work Competition

 The Board of Directors may assign not more than one slide and one print competition each year as a Body of Work Competition. For these competitions, there shall be no class distinction.

 Awards will be presented as in monthly competitions but with no class distinction.
 Print Competition- Each member may enter from 3 to 3. Print Competition- Each member may enter from 3 to 5 images (intended to tell a story, make a statement or support a theme) in both Monochrome and Color competitions. The images will be presented to the judge as a group. Any image which may have won in prior monthly competitions is eligible but no image which has been entered in a prior Body of Work Competition is eligible. All images in the print Body of Work must have been created within the previous 36 months.

4. Slide Competition - Each member may enter 4 images (intended to tell a story, make a statement or support a theme) in the Body of Work Slide Competition. All slides must conform to the vertical format, i.e., no larger than 24 mm wide. Any image which may have won in prior

must conform to the vertical format, i.e., no larger than 24 mm wide. Any image which may have won in prior monthly competitions is eligible but no image which has been entered in a prior Body of Work Competition is eligible. All images in the slide Body of Work must have been created within the previous 36 months.

5. The logistics of the Body of Work competitions will be established by the Competition Committee and published in the newsletter at least two months prior to the competition.

# VI Year End Competitions

1. Each member may enter a maximum of five imagesper

 Each member may enter a maximum of five imagesper category in the year end competition.
 Year end competitions have the same rules as monthly competitions with respect to categories and classes.
 All entries in Year End competitions must have been entered in a monthly competition or as an SSCC entry in an interclub competition during the preceding nine months. However, entries that have won an award in a previous SSCC year end competition are inclinible. previous SSCC year end competition are ineligible.

4. No points will be considered or awarded.

A member who has entered in both the Novice and 5. A member who has entered in both the Novice and Advanced Class of a category during the preceding year may elect to enter either the Novice or the Advanced class (but not both) for the year end competition. If the member enters the Advanced class, he or she may submit any entry previously entered regardless of class. However, if he or she enters the Novice class, he or she may submit only entries previously entered in the Novice class.

6. Awards will be distributed on the following basis: 1st, 2nd, 3rd, and a variable number of HM's equal to 10% of the total entries in that competition, rounded up from odd multiples of five.

multiples of five.

7. The Len Tuchin Award will be presented to the maker of the image that in the opinion of the judges of the Year End Competition, is considered to be the "Best of Show".

# VII Photographer of the Year Awards

 For each class within each competition category a Photographer of the Year Award shall be presented at the year-end banquet.

2. The awards shall be determined on the basis of points

earned during the preceding club year.

3. Point totals shall be calculated as follows:

a. Novice Class

(1). All points earned in SSCC monthly competitions for the Novice class and the Advanced class

of the same category plus....

(2). All points earned as an SSCC entrant in GWCCC and/or CMCC competitions in equivalent categories, any class.

b. Advanced Class

(1) All points earned in SSCC monthly competitions for the Advanced class and 1/2 of all points earned in the Novice class of the same category plus....

(2) All points earned as an SSCC entrant in GWCCC and/or CMCC competitions in equivalent categories any class.

categories, any class.

4. In the event of a tie for Photographer of the Year, the winners will be determined as follows: first tie breakermost 1st place awards; 2nd tie breaker-most 2nd place awards; 3rd place awards awards; 3rd tie breaker-most 3rd place awards.

Inter-Club awards will earn points towards SSCC

Photographer of the Year as follows:

1st place 2nd place 3rd place HM 7 points 5 points 3 points 2 points

except that in competitions where the HM awards exceed 10% of the total competition entries, an HM will only earn 1 point. Entries accepted for club competition in CMCC

will receive 1 acceptance point each.

6. Awards earned by club members entering commercially made prints in interclub competition shall not accrue toward Silver Spring Camera Club

awards.

## VIII Star Merit Certificates

1. For each 50 points scored in monthly club and interclub competitions, total accumulation in all classes and categories over any period of time while a member in good standing of SSCC, a member shall be awarded a Star Merit Award. Stars shall be awarded up to a maximum of five (for a 250 point accumulation). Upon reaching a 300 point accumulation, an SSCC member shall be awarded an SSCC Master of Photography plaque. Upon accumulating 600, 900, and 1200 total points, a member shall receive a special achievement award.

2. The Chairperson of the Competition Committee shall maintain records necessary for the admin-istration of star

3. For purposes of Star Merit awards, points for the merit awards shall be determined on the same basis as Photographer of the Year (par VII).

## IX Service Award

A Service Award may be awarded to the SSCC member who the Executive Council determines has made who the Executive Council determines has made outstanding contributions to further the interests of the Club and its membership. The Executive Council shall make this determination by secret ballot no earlier than May 1st of the award year. The member must receive a majority of the votes cast; if no majority is reached, there may be up to two additional ballots in an effort to achieve one. If no majority is reached after the third ballot, there shall be no award for that were shall be no award for that year.
