Got to hurry with this one. Things have been real busy around here lately. Thanks again for the help, and articles. The deadline for the May newsletter will again be the print meeting.



Slide program speaker for April by Elizabeth Buie





Board Meeting Minutes, March 19, 1996 by Suzanne Izzo....

The meeting opened with the minutes of the February meeting which were approved as read. The Treasurer stated that the Ciub made \$128 on the auction and that our bank account contains over \$4000.

Mike Lux reported back on his work on the Year End Banquet. After some discussion, Clarence Carvell moved that the Club subsidize the banquet up to \$500, with the money to be spent at Mike's discretion. The motion was seconded and passed. Mike has also begun working on getting door prizes. Clarence mentioned that in some of the other camera clubs, some of the master printers had donated prints which were given as door prizes and were much appreciated by the recipients. Mike will look into doing this.

Elizabeth Buie reported that the speaker she had for the April slide meeting had just canceled. She was checking with Bernie Van Leer to see whether he had found a replacement. She will begin looking into acquiring the equipment necessary for the May Body of Work competition.

The New Directions Workshop and its leader, Garry Kreizman, will be in charge of the April print meeting. The discussion will focus on members' photo-mosaics and collages.

Sunday, March 24 is the day for the judging of the spring CMCC competition. Charles Hundertmark was pleased to announce that he received considerably more prints and slides than in the fall.

Steve Stubits as head of the Nominating Committee announced that he has filled all the officer positions for next year. The new slate will be:

Nominations of the Committee will be announced at both April meetings at which time nominations from the floor are accepted. The election will be at the first meeting in May.

Suzanne Izzo suggested that officers prepare a written description of the duties of their office. These could be kept in a file which would be given to the incoming officer. It was suggested that a copy (in electronic form) also be given to our historian, Norm Bernache.

Nominations for the Service Award will be discussed at the May Board meeting. Clarence reminded everyone that the kind of person to receive the award should be someone like Henry Rosenthal who is always ready to step in and help whenever there is a need.

Clarence mentioned that any rule changes must be made in the spring. However, it was felt that no changes need to be made at this time.

The new SSCC mugs were on sale for the first at the auction. Anne Lewis will bring them to Club meetings, and Mike Lux volunteered to be responsible for any mugs which remain unsold at the end of a meeting. The Treasurer will collect the money from the sales. The cost is \$4.

When it was remarked that we have a sizable amount of money in the treasury, Chuck Bress reminded the Board that SSCC has lower costs for meeting space than many clubs. Gary suggested that if money is to be used for improved meeting space, the priority should go to a new room for the print meeting. We need a larger space where there would be facilities to display the prints and (if possible) a place to store equipment. Merl plans to ask for space at the White Oak Library when he submits the request for next year (although it seems unlikely that our assignment will be changed).

Gary brought up an idea which he has presented before to change the name of the Club. He feels that "camera club" sounds too much like a social club and that with digital imaging it no longer accurately reflects the scope of our work. He thought the name might include something like "Photographic Society" or "Imaging". Mike Lux thought that "club" made the group sound more inviting to beginners. However, Chuck replied that one of the largest clubs in the area is the Northern Virginia Photographic Society. Several people mentioned that our Club has a reputation; when they mention that they are members, people say, "That's a good club." It was generally felt that the name should not be changed--especially with our new inventory of mugs with the Silver Spring Camera Club name.

The next meeting will be after the middle of May when Club members return from the trip to France. Merl will set a date and inform the membership.

Our Annual Auction; Laughs and Tears! by Arthur K. Yellin....

Just being at an auction is fun. Being an auctioneer is a blast! In an election year, we will hear all sorts of funny statements, but none will surpass Mike Stein's response to the question, "What is it?"... "What does it matter, it's only one dollar!"

I love the challenge of selling the Yellin Collection and other peoples' no longer wanted paraphernalia (how's that for a euphemism?). I get to describe things I've never seen before and play with the expensive equipment of others. Last night I dropped Stan Klem's demo slide down the wrong slot in the

slide viewer he was selling. I think the slide was instantly teleported to China! I love being heckled by the audience and heckling back. I love the whole gestalt of it ... However, ...

Each year I think back to another SSCC auction; a somber evening when Len Tuchin, long time SSCCer, our delightful auctioneer - always a jokester in that role, said "I don't feel well, seriously!" I remember the valiant CPR efforts of Mike Stein, gruff - but with a heart of gold, to save his friend.

I ask that we all take a moment to remember!

Battery Failure - An Unexpected Adverse Effect by Arthur, the Luddite, Yellin....

In my article on Seattle Film Works and digital imaging, I mentioned that I knew a roll of film had been at least partially ruined due to a battery failure. In fact, what happened was totally unexpected, so I thought I would share the experience with my loyal readers.

For the "blizzard" photos, I was using my idiot proof (HAH, I fooled them) camera, a Minolta 3000i. The battery indicator showed half power, but was blinking at me. Of course, I did NOT read the instruction manual, so I had no idea what the blink meant.

Halfway through the roll, the battery died. No problem ... I opened the battery compartment and replaced the 2CR5 and continued shooting the roll. At the end of the roll, as normal, the camera automatically rewound the film. I took the camera indoors and opened the back. There was still film on the take up spool. It's kind of funny, even an experienced photographer is so amazed upon seeing something like this, that they don't immediately slam the camera back shut! Not only did I hold the camera back open staring at it dumbfoundedly, but I even took it into a different room with a brighter light so I could see what was going on. (Yet more proof that I am human).

Then my brain finally engaged and I rather belatedly slammed the camera back shut and took it into my darkroom (talk about getting the animals back into the barn, huh!). I hand wound the film back into the cassette figuring I'd lost about half the roll. As I later learned, fortunately I'd only completely lost four or six images. Several others are somewhat screwed up because of light fogging, but are still of value for their intended "historical record" purpose.

So what happened? This is my theory ...

When the battery died, the camera's electronic frame memory was reset to zero. When it rewinds it does so in accordance with the frame memory rather than to the end of the film. Since the battery had died when I was about up to frame 12 of a 24 exposure roll, the camera brain thought that only 12

exposures had been shot and only rewound that far with the new battery installed.

Any other theories before I ruin another roll of film?

If this is correct, it is yet another good reason to avoid electronic cameras.

Digital Examination by Arthur K. Yellin....

Last night I was able to stay awake long enough to attend a meeting of the Digital Imaging Workshop, held the home of the steamed, er esteemed, Mike Stein. Having not been at meetings for a while, I was surprised to see my furry friend clean shaven. Apparently, he had to relinquish his beard when he retired from the EPA. Something about an "experimental toxic waste dump" not allowed in public places.

The meeting was attended by about ten people interested in exchanging ideas and learning about digital imaging. This is an area still so new that we are all still pretty much novices at it. The discussions ranged from the need for truckloads of ram chips (computer memory, not chips made of dried goat) to the resolution of images and just what can be expected from consumer level equipment.

Mike made several important points during the evening; with which some I actually agree! Mike noted that while the results of consumer level equipment (scanners and printers under say \$2,000) is not likely to be perfectly photo realistic, it can be quite good and is, if nothing else, fun. He did emphasize that the cost of the equipment and expendables is significant, such that this is no cheaper than conventional photographic methods. Mike also brought out the results of several of his efforts. In my opinion, they were outstanding!

Of note, he brought out several proof sheets which were the product of his consumer level scanner and color printer. Since I am on the verge of buying a scanner, I was particularly interested. Not only that, but I never thought of this use for the scanner. His proof sheets were great; both black and white AND color, and on plain paper. Not photographic, true. But then, I usually have so much variation in my negatives that half of a single proof sheet will be black (or white) while the other half is properly exposed for the negative density. Also, his color proof sheet, from color NEGATIVES, was wonderfully adequate for the purposes for which I use proof sheets. I have never found them to be very useful for judging sharpness, but they are useful for selecting between images for general composition considerations, lighting, etc.

I hate doing proof sheets. Especially from color negatives. It is so time consuming and when you get done, you still have to make a print of whatever single images you select. Here is a fairly painless way to do it. AND, he did it with fairly affordable equipment, without masses of RAM.

I will go ahead and purchase my scanner, with transparency adapter. Watch for comments from the Yellin Testing Laboratory.

Members Exhibiting....

Jay and Marilyn Anderson are currently exhibiting at the International Gallery on New York Avenue in Bladensburg. The show will be up until the end of March. Jay also has a show at the Factory Photo Works, that's in the old Torpedo Factory, for the month of March and will be part of a Factory Photo Works group show at Rock Creek Gallery during April. There will be a reception for that show on Thursday, April 11th. Jay and Marilyn also have work in a current juried group show at the Rock Creek Gallery. Jay's work can be seen anytime (and purchased) at the Factory Photo Works where he is a member.

Clarence Carvell is currently being exhibited at the Maryland Federation of Art on State Circle in Annapolis. One piece in that show recently sold for \$800.00. The show will be up until April 14th. Clarence also has work in a current Maryland Art League juried show hanging at Johns Hopkins University. That work will be up until May 7th. Also hanging is work in a juried member show at Rock Creek Gallery through the month of March. Clarence's work is shown and sold at Margaret Smith's Gallery in Ellicott City, MD, at Touchstone Gallery on 7th St. in Washington, at the Artist's Gallery in Columbia, MD, an at "Sundog", a gallery located adjacent to the shopping center in Fulton, MD.

The Artists' Gallery in Columbia, Maryland is proud to feature new additions to the National Road photography project of Clarence Carvell.

The National Road project began over four years ago out of a desire to document the remaining structures and artifacts associated with the "first highway" of the United States. The project started in the Howard County area and has grown to include remnants of the road from Baltimore to Pittsburgh. In some areas, the road has been rebuilt so many times that it's original location has been lost but, here and there, some evidence still remains. Many of the structures remaining have some historical significance but have never been documented. Finding them continues to be a major part of this work.

Earlier segments of this project have been exhibited at the Allegheny Arts Council, in Cumberland, MD, the Quiet Waters Gallery in Annapolis, MD, the Margaret Smith Gallery in Ellicott City, MD and Slayton House in Columbia, MD. The total collection includes over five thousand negatives and slides.

The Artists' Gallery, is located in the lobby of the American Cities Building on Wincopin Circle, Columbia, MD, features prominent, local, national and international artists working in a variety of media including photography, watercolors, oils and glass.

The exhibition runs from April 29th to May 31st with a reception to meet the artist on Friday, May 10th, from 6 to 8 p.m., Gallery hours are from 12 noon to 6 p.m., Monday through Friday, 10 a.m. to 3 p.m. on Saturday.
